The camp is opened year round with 135 beds and the facility is barrier free. We serve as a host facility for children and adults - some with cancer, diabetes, muscular dystrophy, epilepsy, asthma, autism, developmental delays, or any other type of special challenge. We offer a ropes challenge course, kayaking/canoeing, paddle boarding, archery, swimming, arts, nature music, drama and games. Camp Aranzazu is accredited by the American Camp Association and State of Texas.
